**IIFL Securities Ltd reports strong revenue and profit growth for the quarter & half year ended September 30, 2024**

IIFL Securities Ltd has announced its consolidated financial results for the Q2FY25.

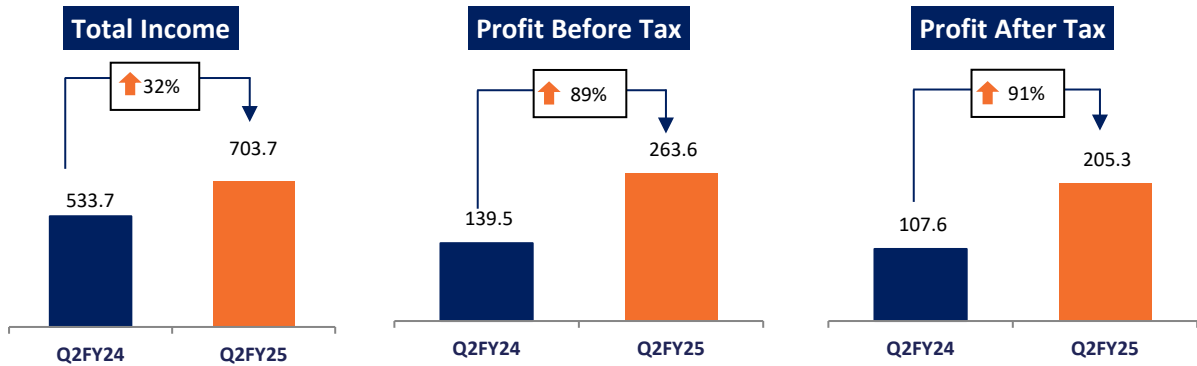
Total income grew **32% on Y-o-Y to ₹703.7 crores** and the growth was led by all the key business segments.

- Total brokerage revenue was up by **17% on Y-o-Y to ₹317.6 crores**.
- Investment Banking revenues were up **35% on Y-o-Y to ₹51.4 crores**. Thirteen deals were consummated during the quarter ended on September 30, 2024.
- Financial products distribution (FPD) revenues went up by **25% on Y-o-Y to ₹106.2 crores**. FPD AUM stood at **₹31,239 crores**.

Profit after tax was up **91% on Y-o-Y to ₹205.3 crores** driven by margin expansion across all the businesses.

As at end September 2024, Distribution & custody assets under management stood at **₹2,46,308 crores**.
